1. DESPITE FACT IT LATE IN GAME BELIEVE WE MUST IMMEDIATELY

WHEREVER POSSIBLE WITHOUT BEING OBVIOUS, REVELATION OF KUBARK PERSONNEL, OPS, OR PLANS SHOULD BE KEPT FROM FRIESEN, AND THOSE KUBARKERS IN CONTACT BUT NOT WITTING SHOULD, UNDER PRETEXT OF GENERAL TIGHTENING OF OUR SECURITY VIS-A-VIS OTHER FOREIGN SERVICES, BE TOLD TO INSURE AGAINST DISCUSSIONS ANY MATTERS NOT DIRECTLY PERTINENT TO AUTHORIZED BUSINESS WITH LIAISON SERVICE PERSONNEL INCLUDING FRIESEN. ALSO WHEREVER POSSIBLE ACTION IN CASES IN WHICH FRIESEN KNOWLEDGEABLE SHOULD BE SLOWED THROUGH ADMINISTRATIVE DELAYS ASCRIBED TO BUREAUCRATIC AND OTHER OBSTACLES.
