GIVEN CIRCUMSTANCES CITED REFS, WE NOT OPTIMISTIC RE POSSIBILITY SECURELY DETECTING POSSIBLE SINISTER ACTIVITY OF UJDRUM, EVEN WITH MAJOR SURVEILLANCE ACTIVITY WHICH WOULD BE VERY DIFFICULT GIVEN OUR PRESENT OPS COMMITMENTS. HOWEVER WILL INITIATE TRY, BEGINNING WITH LOOSE SURVEILLANCE UJDRUM ON ARRIVAL TEMPELHOF MORNING 6 JULY TO TRY PINPOINT WHERE HE WILL STAY. THIS LIKELY BE TOUGH WITHOUT PHOTO UJDRUM. IF POSSIBLE SUGGEST MUNI SEND COURIER WITH PHOTO SOONEST.

2. PRESENT OPINION, BASED ON VERY LIMITED INFO RE FALL BANANE, THAT SURVEILLANCE UJDRUM DURING UKDRUG MEET WITH WICHODIL NOT LIKELY

PRODUCE ANYTHING RE UJDRUM POSSIBLE SINISTER ACTIVITY AND MIGHT  
DAMAGE UPHILL OP IF SURVEILLANCE DETECTED BY UJDRUM, UJDRUG OR  
POSSIBLE EAST GERMAN CONTACTS OF WICHODIL.

3. CAN ONLY DECIDE RE POSSIBLE TRY COVER UJDRUM AT HOTEL OR
