1. UJDRUM ARRIVED PANAM 640 ABOUT 0935 HRS 9 AUG. STAFF SURVEILLANTS IN POSITION OUTSIDE TERMINAL AND THUS UNCERTAIN WHETHER FOLLOWING PERSON MET OR ACCOMPANIED UJDRUM: ESTIMATED AGE 60, HEIGHT ABOUT FIVE ELEVEN, STOCKY, PEAR-SHAPED FIGURE, WEIGHT ABOUT 200 LBS., SALLOW COMPLEXION, WORE GLASSES, VERY LIGHT THINNING HAIR, HALF BALD, CARRIED DARK BROWN OVERNIGHT CASE. BOB CAN NOT IDENTIFY. UJDRUM AND COMPANION TOOK TAXI TO HOTEL BERLIN ARRIVING ABOUT 0955. BOB SURVEILLANT NEAR RECEPTION DESK DETERMINED UJDRUM REGISTERED

NAME "BERGER" FOR ROOM 220.

2. DIFFERENT TEAM BOB STAFFERS SURVEILLED UJDROWSY ARRIVAL.  
ACCOMPANIED BY UJDRUG AND ALIAS FRAULEIN PAUL HE ARRIVED PANAM  
690 ABOUT 1125 HRS. UJDRUM MET THEM. ALL CHATTED FOR SEVERAL  
MINUTES. GOOD CLANDESTINE PHOTOS TAKEN. TWO CARS WERE READY FOR  
GROUP. SEATED IN FIRSTCAB WERE UNIDENTIFIED MAN, SIXTYISH, POSSIBLY  
IDENTICAL WITH "BERGER" PARA 1 ABOVE, AND SECOND UNIDENTIFIED MAN,  
FORTIES OR FIFTIES, APPARENTLY ABOVE MEDIUM HEIGHT, DARK HAIR. CABS  
PROCEEDED TO HOTEL BERLIN, WHERE APPEARED UJDROWSY AND UJDRUG  
ALSO REGISTERED. SUBSEQUENT INFO FROM TAP ALIAS BORG OFFICE IN-  
DICATED ALIAS FRAULEIN PAUL LATER RETURNED TO OWN LOCAL QUARTERS.

3. MORNING 9 AUG AFTER DISCUSSION WITH            WE PROCEEDED  
TO SMALL PROVOCATION RE FALL BANANE. IN RECENT LOCAL FILE SEARCH-  
ING WE UNCOVERED MARIENFELDE REFUGEE SCREENING CARD FOR JUERGEN  
KLAUS SEBEKOW, BORN 3 OCT 42, IN WHICH KARL HEINZ WICHODIL ACCUSED  
OF BEING MFS AGENT. WITH THIS IN MIND AS ULTIMATE BACKSTOP IN EVENT

ANY UPHILL QUERIES AND USING INFO PARA 2 REF A WE ASKED U.S. LIAISON OFFICER TO WEST BRLN POLICE TO INQUIRE FOR INFO REGARDING "RECENT INCIDENT INVOLVING SOME MINOX FILM AND MAN NAMED WICHODIL". REQUEST FRAMED SO EITHER POLICE OR UPHILL MIGHT CONCLUDE WE TIPPED TO MATTER BY SOMEONE IN POLICE.

4. EARLY AFTERNOON 9 AUG WE RECD ABT I FILE RE WICHODIL PLUS COPIES LETTERS 4 AND 8 AUG WHICH HE SENT TO ABT I AND DEVELOPED COPIES MINOX FILM. POLICE FILE SHOWS WICHODIL SUSPECTED BY LFW BRLN AS MFS AGENT. HIS CASE REFERRED TO POLICE JUNE 60 FOR INVESTIGATION ON CHARGES MAINTENANCE TREASONABLE CONTACTS. POLICE FILE CONTAINS CHARGES BY JUERGEN KLAUS SEBEKOW PER PARA 3 ABOVE AND CONFUSED AND PHONEY SOUNDING STATEMENTS BY WICHODIL RE HIS PAST CONTACT WITH MFS AND ALLEGED CURRENT AFFILIATION WITH UNDISCLOSED "WESTERN OFFICE". INFO FROM LANDESKRIMINALPOLIZEI HANNOVER SHOWS WICHODIL BETWEEN 37 AND 54 SIX TIMES CONVICTED CRIMINAL CHARGES.

5. WICHODIL LETTERS TO ABT I VOLUNTEER SERVICES AS INFORMANT RE MFS, CONTAIN TYPED REPORTS RE ALLEGED MFS AGENTS INCLUDING

JUERGEN KLAUS SEBEKOW CITED ABOVE. 4 AUG LETTER CONTAINS TYPED REPORT RE ALLEGED MFS AGENT GERTRUD THIEM OF WERDER, KREIS POTSDAM, NOTES SUMMARY THIS INFO "TODAY PASSED TO AN OFFICE IN FEDREP". 6 AUG LETTER REQUESTS POLICE MEET WITH WICHODIL ON 7 AUG SINCE IMPORTANT UNSPECIFIED EVENTS WILL HAPPEN ON 8 AUG. COMMENT - OUR IMPRESSION BASED POLICE FILE AND OTHER INFO AVAILABLE IS THAT WICHODIL INTEL FABRICATOR POSSIBLY ALSO UNDER MFS CONTROL.

6. NOT FEASIBLE PLACE CALLIKAK ON HOTEL BERLIN. IN ABSENCE ANY INFO PINPOINTING TIME FALL BANANE MEET AND IN VIEW DIFFICULTY SURVEILLING HOTEL BERLIN WE DECIDED TRY AFTERNOON PHOTOTRUCK

STAKEOUT NEU WESTEND U-BAHN AREA. COVERAGE 1445 TO 1615 HRS PRODUCED NOTHING.

7. AFTER RECEIPT REF C CHECKED FOR POSSIBLE INFO RE "KAULBACH" CITED REF OR PURPOSE 10 AUG MEET MENTIONED. NO BOB TRACES. NO CLUES VIA TAP ALIAS.BORG OFFICE TO WHICH ALIAS FRAULEIN PAUL RETURNED ABOUT 1600 HRS. IN ABSENCE ANY INFO RE LIKELY PLACE 10 AUG MEET AND GIVEN DIFFICULT SURVEILLANCE SITUATION AT HOTEL BERLIN, WE DECIDED

NOT TRY SURVEILL HOTEL BERLIN GROUP TO TRY SPOT MEET. AS OF NOON

10 AUG NO CLUES TO MEET VIA TAP ALIAS BORG PHONE OR ANYTHING ELSE.

8. ONLY OTHER POSSIBLY SIGNIFICANT ITEM IN RECENT ALIAS BORG TAP IS 2 AUG TALK BETWEEN ALIAS FRAULEIN PAUL AND ALIAS DR VOGEL IN WHICH PAUL REFERS TO PHONE CALL RECD FROM UJDROWSY ON 1 AUG INQUIRING WHETHER VOGEL WILL BE ABLE TO DO SOMETHING "IN DIESER SACHE BANANE, MIT DEN DEISEN". VOGEL MUMBLES EXCUSES, SAYS 2 AUG QUERIED "SACHBEARBEITER" BUT IT DIFFICULT GET THINGS DONE BECAUSE OF VACATIONS. PAUL SAYS WILL INFORM UJDROWSY.

9. WE REMAIN CONFUSED RE SIGNIFICANCE RECENT ACTIONS UJDROWSY AND COMPANY. AGREE UJDROWSY TRIP RE FALL BANANE IS WEIRD ESPECIALLY VIEW FACT EVEN BASIC VETTING OF WICHODIL BY UPHILL WITH WEST BRLN POLICE SHOULD HAVE UNCOVERED HIS DUBIOUS RECORD. QUERY WHETHER ANY SUCH CHECKING EVER DONE AND IF SO WHETHER UJDROWSY POSSIBLY HOLDING OUT INFO.

10. PER DISCUSSION WITH [ ] NO BOB OBJECTION IF UPHILL CE INCLUDING UJDROWSY APPROACHED WITH STORY RESULTS BOE CHECK RE WICHODIL WITH POLICE, IF NECESSARY ATTRIBUTING TIMING OF CHECK TO
