RE PARA 7 REF, WOULD APPRECIATE INFO RE NUMBER EXITS HOTEL BERLIN AND OTHER FACTORS MAKING SURVEILLANCE COVERAGE DIFFICULT. NOTE WE RELUCTANT TELL UPHILL WE DID NOT EVEN TRY SURVEILLANCE COVERAGE UJDROWSY AND UJDRUM MORNING 10 AUGUST UNLESS WE CAN PROVIDE FEW FACTS RE HOW TOUGH TARGET WAS. UPHILL MORE OR LESS CONVINCED UJDROWSY AND UJDRUM WERE PLANNING CLANDESTINE MEETING WITH RIS AND WILL BE PUZZLED WHEN ADVISED WE DID NOT ATTEMPT COVERAGE.
