1. RE PARA 3 REF, FEEL UPHILL WILL BE RELUCTANT PROVIDE DOC OTHER THAN NORMAL LIAISON IDEN DOC WHICH LIKELY BE RECOGNIZED BY POLICE AS AUTHENTIC. BELIEVE DOC IN QUESTION SAME AS UPHILL STAFF IDEN DOC EXCEPT FOR COLOR AND EXPLANATORY TEXT ON BACK. INCLINED DOUBT ANYTHING OTHER THAN NORMAL UPHILL DOCUMENTATION WOULD SERVE MUCH PURPOSE. IN EVENT FLAP POLICE WOULD NOT UNDERSTAND WHY REGULAR UPHILL DOCS NOT USED AND SUSPECT FORGERY. TELEPHONE CALL AND DIRECT UPHILL INTERVENTION WOULD THEN BE ONLY THING THAT WOULD HELP.

2. IF UPHILL DOCS DESIRED, REQUEST POUCH PHOTOS AND OPS ALIASES FOR DOCS, WHICH SHOULD BE BACKSTOPPED WITH PHONY AGO CARDS. IF HQS DOES NOT WISH MAKE PHOTOS AVAILABLE UPHILL, ADVISE AND WE WILL GET UPHILL VIEWS RE BEST POSSIBLE ALTERNATIVES.
