1. SINCE SENDING YOU MY YESTERDAY MESSAGE WITH UPHILL<sup>1</sup>  
LETTER RE MEXICO AFFAIR, I HAVE GIVEN FURTHER THOUGHT AS TO  
EXTENT OF OUR PARTICIPATION. IT WAS ONLY YESTERDAY THAT I HAD  
HAD BRIEFING ON THE SERIOUSNESS AND EXTENT OF RAMIFICATION OF  
THIS MATTER. OBVIOUSLY UPHILL<sup>1</sup> GREATLY DISTURBED AND I BELIEVES THIS COLOR<sup>1</sup>  
HIS VIEWS AS TO GRAVER POLITICAL ISSUES DISCUSSED IN  
TODAYS CABLE AND HIS OWN READINESS TO MEET THEM.

2. WHILE I BELIEVE WE SHOULD RENDER ALL PROPER TECHNICAL  
AND OTHER AID VIEW OUR BACKGROUND KNOWLEDGE OF [ ]<sup>2</sup> CASE,  
I HAVE SOME DOUBT WHETHER WE SHOULD ALONE ASSUME RESPONSIBILITY  
FOR CERTAIN ACTS BRINGING US INTO CONFLICT WITH GERMAN LAWS.
