Transmitted herewith are the CALLIKAK intercepts for the period 15 September to 16 October 1961 concerning the Karl-Heinz WICHODIL family, the Fritz LOSIGKEIT family, and a mail intercept to Alfred BRUCHMANN.</p> <p>2. On 6 October 1961 CALLIKAK informed BOB that information from West Berlin postal authorities indicated that Alfred BRUCHMANN had moved from Bruederstrasse 40, Berlin-Spandau, to Johannastrasse 1 bei WUTTIG. (BOB files indicate that among the residents at this address are Herr Wilhelm WUTTIG, shown in a 1957 address book as proprietor of a textile and paper firm, and Frau Margarete WUTTIG, shown in the 1961 address book as the proprietor of an unidentified firm.) A CALLIKAK note added that a check with the West Berlin police had shown that BRUCHMANN had deregistered from West Berlin; his intended new address was given as Suelzener Guertel 86, Koeln. CALLIKAK coverage on the Bruederstrasse 40 address, including telephone 37 76 19, was cancelled effective 9 October 1961. CALLIKAK coverage of the Johannastrasse 1 address has not been instituted because of the apparently temporary nature of BRUCHMANN's stay there. Such coverage can be instituted if MLB desires. Please advise.</p>
