1. ALIAS BERNHARDT REPORTS LEGAL AUTHORITIES AGREEABLE PARA 1
REF PLAN WITH EXCEPTION THEY INSIST ARREST UJDRUM MUNICH AIRPORT
AFTER HE HAS GONE THRU GATE TO AIRFIELD, SINCE THIS SUFFICIENT
INDICATE HIS INTENT.
2. COMPLICATING FACTOR IS UPHILL JUST RECEIVED LETTER DATED
1 NOVEMBER FROM MOTHER IN LAW BANANE TO GLOBKE STATING SHE RECEIVED
LETTER DATED 27 OCTOBER FROM FRAU BANANE SAYING SHE AND BANANE
ARRESTED 23 OCTOBER EAST BRUN. SHE RELEASED AFTER SEVERAL HOURS,
BANANE RETAINED. LETTER TO GLOBKE DID NOT SAY WHICH EAST ORGAN
NOTED ARREST OR WHAT CHARGES WERE BUT COMPLAINED THAT ARREST

KNOWN TO MOTHER IN LAW WHO ONCE HAD MET CASE OFFICER.

3. UPHILL BELIEVES ARREST EITHER MISTAKE DUE LACK EASTERN
COORDINATION OR DONE BY POLICE ON CRIMINAL CHARGES. WHETHER BANANE
STILL JAILED UNKNOWN BUT WOULD SEEM UNLIKELY SINCE ENOUGH TIME HAS
PASSED PERMIT COORDINATION UNLESS SOMETHING SINISTER INVOLVED.

4. ANY EVENT UJDROVSY WILL BE INFORMED OF ARREST 3 NOVEMBER AND
CAN BE EXPECTED INFORM RIS.
