REFERENCE(S)

1. On 18 January 1962 CARAVEL handed his FOB case officer, [] a photocopy of the Bundeskriminalamt file on Heinz FELFE, thinking it might prove of interest to us. When he gave it to [] he observed that FELFE had applied for a job in 1950 but had been refused employment although CARAVEL did not know the specific reasons. (Perhaps FELFE's Nazi record contained in the Berlin Documents Center report or his failure to provide adequate references may be the explanation.) CARAVEL also observed that UPHILL refuses to trace their candidates for employment with the BKA although doing so would undoubtedly save them much grief. For one thing, said CARAVEL, there was often much information in the BKA files on people who had applied for employment and had been turned down which would be useful to an organization running a security investigation on someone.

2. Because CARAVEL handed the file to us "unofficially," it is as you know for KUBARK use only. We delayed sending this to you for we had hoped that at his next meeting with his case officer, scheduled for a week later, CARAVEL could tell us the specific reasons for the BKA's turn-down of FELFE. Unfortunately CARAVEL was accompanied by another member of his office at that meeting so that a private conversation with his case officer was not possible. Rather than risk another unforeseen delay we are sending the file to you now and will report such further details as CARAVEL can tell us when we get them.
