1. IN PRINCIPLE WOFIRM INTERESTED IN DIRECTLY DEBRIEFING SONNTAG AND NAUMANN, BUT THIS NOT DESIRABLE AS EARLY AS 20 FEBRUARY. FIRST, PREFER CHANCE REVIEW CATUSK DEBRIEF AND HAVE READING ON SUBJECTS DISPOSITION TOWARDS TALKING WITH LNHARP REPRESENTATIVE.

2. TO MAINTAIN LONG STANDING PUBLIC REPEAT PUBLIC DENIAL OF LNHARP INVOLVEMENT, MAJOR OBJECTIVE MUST BE EFFORT PERSUADE SUBJECTS ACCEPT GUIDANCE ON NOT PUBLICIZING STORY WHICH IN NEITHER THEIR NOR FEDREP INTEREST.
