1. ALIAS BERNHARD, WHO NOW RESPONSIBLE FOR PRISONER EXCHANGE MATTERS, REPORTS HA SINCE UJDROWSY EXCHANGE EAST ZONE HAS INTENSIFIED EXCHANGE ACIVITY AND APPARENTLY BENT ON COMPLETION PROGRAM.

2. LATEST ATTEMPT IS GET YURIY N. LOGINOV FOR WHICH DDR WILLING GIVE UP ANY TEN WESERN AGENTS. TO DOCUMENT FARCE THAT LOGINOV EAST GERMAN CITIZEN, THEY HAVE PROVIDED FORGED DOCUMENTATION ATTESTING HE BORN AND RESIDING ERESDEN, NOTWITHSTANDING FACT HE SPEAKS NO GERMAN.

3. SELEVER APPARENTLY AGREEABLE TO EXCHANGE PROVIDED IT DONE QUIETLY AND WITH SAFE GUARDS AGAINST FLAP. BERNHARDT WILL FACILITATE EXCHANGE WITH CHARED LUFTHANSA FLIGHT DIRECT TO FRANKFURT AND HENCE TO BORDER. PLANS CHARGE COST OF 200,000 DM TO CAVERVE FUND AND DEMAND FIVE EXTRA PRISONERS AT DM 40,000 WHICH GOING PRICE.
