ACCESSION TO POWER IN 33. FRAENKEL KNEW UJDROWSY CASUALLY

IN STRAUBING PRISON UNTIL 68 WHEN FRAENKEL WAS PAROLED.

UJDROWSY LETTER CAME AS SURPRISE TO FRAENKEL WHO BELIEVES

THAT UJDROWSY LEARNED OF HIS EMPLOYMENT FROM PRISON CHAPLAIN

WITH WHOM FRAENKEL CORRESPONDS. BELIEVES THAT

FRAENKEL EMPLOYMENT ARRANGED BY CLOSE FRIEND
