<p>1. Since the appearance of the article mentioned in referenced cable, we have had an opportunity to discuss the matter further with @Bernhardt. He informed us that @Fleming had interviewed the <u>Abendzeitung</u> reporter and had determined that he was leftist oriented and not to be persuaded that he was dealing with a KGB agent in the person of UJDROWSY. His primary motive appeared to be to obtain the exclusive rights to UJDROWSY's memoirs.</p> <p>2. At about the same time, CATRIBE called the <u>Abendzeitung</u> article to the attention of the Inner German Ministry. This ministry, without any attribution to CATRIBE, passed to the East Germans via the Stange-Vogel channel the admonition that the announcement of UJDROWSY's intent to publish his memoirs was in contravention to the agreement reached at the time UJDROWSY was exchanged under which neither side was to engage in any publicity on the case. Subsequently, CATRIBE intercepted a letter from UJDROWSY to his daughter. In it he invites his daughter to visit him but at the same time cautions her not to mention his letter or her trip to the <u>Abendzeitung</u> reporter "because he has awakened sleeping dogs". This appears to be a reference to the admonition passed by the Inner German Ministry.</p> <p>3. @Bernhardt stated that he planned to have another session with the <u>Abendzeitung</u> reporter but was not sanguine about persuading this man to cease and desist from continuing with contact to UJDROWSY. @Bernhardt has promised to inform us as to further developments.</p>
