A. STATES IN SUBSTANCE THAT JKLANCE CONTRIBUTED TOWARD UJDROWSY'S RELEASE FROM PRISON IN 1969 BY HAVING INVOLVED TWO HEIDELBERG STUDENTS () IN FRIVOLOUS SPYING ADVENTURE IN SOVIET UNION IN 1961 WHICH LED TO THEIR ARREST BY SOVIET AUTHORITIES WHO LATER ABLE TO EXCHANGE THEM FOR UJDROWSY.

B. "SPIEGEL" ARTICLE OF NOVEMBER 1961 WHICH ALLEGES THAT AELADEL WHO DEFECTED TO JKLANCE EXPOSED UJDROWSY AS A KICK AGENT IS CITED AS ONE OF NUMBER OF REPORTS WHICH FALSELY ALLEGE THAT CATRIBE HAD OUTSIDE HELP IN EXPOSING UJDROWSY.
