FISCHER Eduard

02 USFA files contain a Personality Case File, subj: FISCHER Eduard, born 24 Jan 1901.

This file contains a letter dtd 16 Jan 1947 from the Czech War Crimes Investigating Team in Austria which is headed "Request for Extradition". This letter requests that the US Government through its military government in Austria arrest and surrender to the Czech War Crimes Investigating Team in Austria one Eduard FISCHER born 24 Jan 1901, citizen of Germany and "now being detained in Camp Marcus W. Orr or Elense, US Zone of Austria who is wanted for the following offenses:

As head of Gestapo in PILSEN Czechoslovakia since May 1944 until May 1945 he was responsible for all imprisonment torture and deaths of hundreds of Czech patriots during that period particularly numerous members of underground organizations "ESTRA" and ETA leaders A. SMIL, and A. CHVALIK, who were executed on his order. As superintendent in the notorious police jail in TEREHN during the whole war he is responsible for all atrocities committed there by German guards against thousands of Czechs."

A 02 DF forwards this letter to CTS Kinz and requests that Subject be apprehended and interned in Camp Marcus W. Orr pending extradition to Czechoslovakia. DF is dated 19 Feb 1947.
