1. 14 APR SUBJ RCVD CARD FROM DR A. MARTIN, (RETIRED) POLICE INSPECTOR LIVING SCHOENAU, BERCHTESGADEN, HAUS BAERENWINKEL, ASKING FOR MEETING 16 APR. SUBJ MET MARTIN WHO FIRST ASKED SUBJ IF HE KNEW POLICE INSPECTORS HILLIGES AND CLEMENS. SUBJ STATED HILLIGES UNKNOWN HIM, THOUGHT CLEMENS IN PRAGUE PRISON. MARTIN STATED HE STARTING (CE) ORG, WANTED SUBJ PL/N ORG FOR HIM AT GOOD SALARY, AMOUNT NOT SPECIFIED. MARTIN FURTHER STATED HE FINANCIALLY SUPPORTING ALONE, ALSO THAT HE IN CONTACT WITH FNU NAUXON AND COL FNU TARZER UNKNOWN TO SUBJ.

2. SUBJ STATED HE OTHERWISE EMPLOYED, NOT INTERESTED THIS KIND WORK, REFERRED MARTIN TO OLD FRIEND RETIRED POLICE INSPECTOR HEINZ FENNER IN MURNAU (ALSO RECEIVED MURNAU) AS ONE WHO MIGHT BE INTERESTED.

3. SUBJ STATED ACQUAINTED MARTIN 20 ODD YEARS, MARTIN IN REICHSICHERHEITS HAUPTAMT BERLIN (33 THRU 35) ALSO ASSOCIATED KAMPFKOMITEE FUER FRIEDEN UND FREIHEIT UNDER DR FNU TAUBERT (PROBABLY IDEN A AND IDEN B). FENNER WAS ABWEHR SPECIALIST ON USSR IN BERLIN, SUBJ THINKS NOW WORKS FOR UPSWING.

4. REQUEST TRACES ABOVE PERSONS. PULL: U.S. FILES ONLY.
