1. PLS INFORM G2 AND ODOPAL FOLLOWING:

A. BEST POB KNOWLEDGE UPSWING PRESENTLY NOT RUNNING ANY OPS IN WHICH PBPRIME BUILD-UP MATERIAL PASSED WITHOUT PROPER CLEARANCE. THIS INCLUDES UJDROLL-ERRIES NUMBER 302, 304, 308 ON WHICH WILL FORWARD SPECIFIC COMMENTS BY DISPATCH.

B. HOWEVER WISH TO DRAW G-2 AND ODOPAL ATTENTION TO ONLY KNOWN INSTANCE IN WHICH UPSWING VIOLATED AGREEMENT AND DID PASS PBPRIME MILITARY MATERIAL WITHOUT OUR KNOWLEDGE. THIS CASE OF EMIL DWORAK, BORN 15 JULY 1911. NOTE D. ORIGINALLY RUN BY REGION IV, THEN APPARENTLY DROPPED.

C. WHEN CHALLENGED D CASE, UPSWING HAS FOUND ITSELF IN INDEFENSIBLE POSITION, REALIZED LOW NATURE MATERIAL NO EXCUSE, FULLY AWARE PRINCIPLE INVOLVED. BEST OUR JUDGEMENT FAILURE TO CONSULT POB AND ASK FOR G-2 CLEARANCE VIA THIS CHANNEL DUE TO LACKADAISICAL UPSWING DESK OFFICER WHO HAD ODVIOUSLY HARDLY READ MATERIAL INVOLVED AND UPSWING BUILDUP CONTROL OFFICER WHO HONESTLY THOUGHT INFO TOO PRIMITIVE AND OVERT TO MERIT ATTENTION.
