1. REF WAS OUR FIRST INDICATION ODOPAL DISSATISFIED HANDLING TURNOVER. THROUGHOUT NEGOTIATIONS ~~ODOPAL~~ RAISED NO ARGUMENTS MAINTAINED SEEMINGLY CORDIAL ATTITUDE VIS A VIS ~~EXCEPT~~ EXCEPT FOR CAPT WALLACE WHO CLEARLY VIEWS UPSWING ACTION THIS OPS AS DEMONSTRATED BAD FAITH DESPITE THEIR APOLOGIES TO THEM VIA POB. POSSIBLY WALLACE ALSO REGARDED OUR MIDDLEMANNING UPSWING OFFER TURN SUBJECT OVER TO ODOPAL AS SUSPICIOUS DESPITE PLEA WE NOT TRYING SELL CASE BUT SIMPLY WANTED ODOPAL DECISION WHETHER THEY INTERESTED TAKE OVER.

2. PHONE CALL REGION IV SUBSEQUENT RECEIPT REF CONFIRMED COMPLAINT ORIGINATED REGION IV AND DID NOT REPRESENT ONLY GROUP VIEWS. ALSO LEARNED VIA MUNI'S ~~THAT~~ THAT REGION IV DISSATISFIED FROM BEGINNING.

3. R-IV RAISED NO OBJECTIONS TO TURNOVER ARRANGEMENTS AS ORIGINALLY PROPOSED BY POB. THESE DID NOT INCLUDE MEETINGS BETWEEN UPSWING AND ODOPAL HANDLERS. SUBSEQUENTLY CAP CALLAHAN DID RAISE POINT AS AFTERTHOUGHT. ~~STATED~~ STATED THIS NOT POSSIBLE SINCE UPSWING TRADITIONALLY UNWILLING EXPOSE FIELD PERSONNEL. CALLAHAN DID NOT PRESS POINT NOR INDICATED THIS A CONDITION RE TURNOVER. NOTE THAT FIRST

SESSION WITH ODOPAL INCLUDED 10 TO 12 THEIR STAFFERS BUT NEITHER THEN NOR LATER WAS ANYONE IDENTIFIED TO POB AS OPS C/O IF HE WAS PRESENT.

4. RE UPSWING HANDLING INFO, WE REPEATEDLY ASSURED R-IV WE TRYING GET ALL WE COULD FOR THEM BUT CAUTIONED THEY COULD NOT EXPECT "COMPLETE UPSWING FILE", EXPLAINED THIS DUE CLERICAL PROBLEM OF UPSWING NOT ABLE HAVE SOMEONE SANITIZE ALL INTERNAL UPSWING CORRESPONDENCE. ACTUALLY IN ADDITION TO ATTS EGLA 24772 WE GAVE R-IV UPSWING SUMMARY REPORT PLUS ANY AND ALL INFO WE HAD INCLUDING ITEMS NOTED FROM READING FILE AT UPWSING HQS. THUS WHILE INFO PROVIDED WAS NOT "COMPLETE", IT WAS MORE THAN EXPECTED AND HONESTLY REPRESENTED BEST POB EFFORT. ALSO R-IV RAISED NO SPECIFIC QUERIES WHICH WE WOULD HAVE TRIED TO SERVICE.

5. FRAN STUT: TURNOVER ARRANGEMENTS FOR INITIAL ODOPAL CONTACT 11 JULY. BASIS   INFO ODOPAL MAY HAVE REVERSED THEMSELVES AND DECIDED NOT RUN CASE AFTER ALL. PLS CLARIFY. IF ODOPAL WILL NOT RUN, UPSWING PLANS TURNOVER TO CAVIRIL.

6. BELIEVE ANY FUTURE DEALINGS WITH ODOPAL THIS MATTER BEST HANDLED BY STUT AND FRAN.
