THE BASIS FOR THE TERMINATION, SO FAR AS CAPEDAL/1 IS CONCERNED, WILL BE THAT WE CAN NO LONGER AFFORD THE AMOUNT THAT WE HAVE BEEN PAYING, IN SALARY AND EXPENSES, FOR THE FUNCTION THAT HE HAS BEEN PERFORMING. CAPEDAL/1 WILL FURTHER BE TOLD THAT THE OFFICIAL INVESTIGATIVE FUNCTION HE HAS BEEN CARRYING OUT WILL BE TURNED OVER TO ANOTHER UNIT WHICH WILL PERFORM INVESTIGATIONS FOR A VARIETY OF MILITARY AND INTELLIGENCE UNITS IN THIS AREA.</p> <p>B. CAPEDAL/1 HAS NOT LEARNED THAT [] BEEN HIRED AND THERE WILL BE NO PERSONAL CONTACT BETWEEN CAPEDAL/1 AND [] SHOULD CAPEDAL/1 LEARN THAT [] IS PERFORMING THE FUNCTIONS WHICH HE PREVIOUSLY PERFORMED, THE FACT THAT [] IS AN AMERICAN SHOULD LEND CREDENCE TO OUR STATEMENT THAT INVESTIGATIONS WILL, IN THE FUTURE, BE CARRIED OUT ON A CENTRALIZED BASIS. 2. RE PARAGRAPH 2 OF REFERENCE - WE SHOULD HAVE LIKED TO TERMINATE CAPE DAL/1 EFFECTIVE 1 JANUARY. SINCE WE CANNOT, HOWEVER, TERMINATE HIM BY THAT DATE AND STILL MEET THE CONTRACTUAL THIRTY DAYS NOTICE, TO SAY NOTHING OF THE SIX WEEKS WE INTEND, IT IS LIKELY THAT THE EARLIEST DATE WE CAN TERMINATE CAPE DAL/1 WILL BE 31 JANUARY 1963. THE EXACT DATE TO BE SELECTED WILL DEPEND ON THE RECEIPT OF HEADQUARTERS' APPROVAL TO PAY CAPE DAL/1 THE DM 15,000 TERMINATION BONUS. WE SHALL NOT INFORM HIM HE IS BEING TERMINATED UNTIL ALL FINANCIAL ARRANGEMENTS ARE APPROVED.

3. THE PROJECT RENEWAL REQUESTED IN PARAGRAPH 3 AND THE PRQ PART II REQUESTED IN PARAGRAPH 4 OF REFERENCE WILL BE FORWARDED IN THE NEAR FUTURE.
