<p>1. Transmitted under separate cover are CAPEDEL-1's Quitclaim, Final Secrecy Agreement, and Agent Service Record. A review of the MOB file on CAPEDEL-1 indicates that copies of all documents of permanent record value, other than those being transmitted with this dispatch, are already available at Headquarters. The MOB files will, however, be retained for the foreseeable future for the reasons indicated below.</p> <p>2. Although CAPEDEL-1 has been formally terminated, we have remained in contact with him due to the inherent security considerations involved, and the fact that CAPEDEL-1 is not yet resettled to his or our satisfaction. CAPEDEL-1 accepted his termination gracefully to all appearances but he was nonetheless most upset due to the fact that he has to both support himself and make payments into a voluntary pension fund for two more years before he will be eligible to retire with a steady income. (He is no longer entitled to any kind of pension based on his former service with the German Government.) Both MOB and CAPEDEL-1, himself, have devoted a great deal of effort to finding him a job in a non-intelligence capacity. Due to his age this has proven impossible.</p> <p>3. When it became apparent that he would not be able to obtain a non-intelligence job, MOB offered him to the other ODYOKE services in this area. ODUNIT expressed an interest in him and he was, in fact, interviewed for employment in April 1963. To date, however, neither MOB nor CAPEDEL-1 have heard anything further from ODUNIT and no firm job offer has been forthcoming.</p> <p>4. CAPEDEL-1 quite naturally requested permission from the beginning to seek employment with either UPHILL or CAVIRIL. Although we do not consider it to KUBARK's interest to have him with either organization, we finally gave him permission to contact CAVIRIL through [ ] (whom CAPEDEL-1 knows by reputation). This action was taken because we realize that we cannot actually prevent him from going to UPHILL or CAVIRIL, the more so since CAPEDEL-1 is aware that [ ] did so with KUBARK's blessings. To date, CAPEDEL-1 has not received a firm job offer from CAVIRIL and is still negotiating with them. If he is unable to obtain a job with CAVIRIL we shall ultimately agree to his contacting UPHILL.</p>
