1. SUBJ IS CAPEDAL FORMERLY CASTONE-4 AND CACUS-4. MOB EMPLOYEE 17 OCT 52 TO 15 MAR 63. WAS CHIEF SURVEILLANCE TEAM TO 1956 THEN MOB CHIEF INVESTIGATOR UNTIL 63. DID MOST BASE EMA CHECKS. TERMINATED GROUNDS OF AGE, EXPENSE AND OVEREXPOSURE WOFIRM ACTIVITIES AND STAFF EMPLOYEES. TERMINATION BONUS DMW 15,000. (INCORRECT - see quit claim)

2. AT TIME TERMINATION THOROUGHLY CHECKED LNREAD HANDLING SIMILAR CASE. LNREAD EMPLOYEE WITH SIMILAR OVERT POSITION, SIMILAR SALARY AND LENGTH OF SERVICE ENTITLED TO SETTLEMENT OF DMW 12,000 IN ACCORDANCE GERMAN LABOR LAW TO WHICH LNREAD CONFORMS. SUBJECT WAS GIVEN DMW 3,000 MORE THAN REQUIRED PLUS SIX WEEKS NOTICE NOT FOUR AS STATED CONTRACT. DOUBT THESE FUNDS DECLARED TAX AUTHORITIES. (HR)
