ON BASIS PAST DEALINGS WITH CATUSK, CONCLUDE WOFIRM REQUEST FOR ACTION ASSISTANCE IN CAPELAL CASE WILL EVOKE SYMPATHETIC REACTION BUT WILL BE FOLLOWED BY RECOMMENDATION WE CONSULT WITH CAWHISPER AS ONLY APPROPRIATE MMBRUSH AGENCY. SINCE CATUSK HAS HAD SIMILAR PROBLEMS AND HAS HAD RELATIVELY POOR SCORE, THEY MAY AT A MINIMUM BE ABLE OFFER SOME ADVICE.

2. FOR THE RECORD WISH POINT OUT THAT DURING INTERVIEW WITH , CAPELAL DID NOT RPT NOT STATE THAT HE INTENDED UNDERTAKE COURT ACTION IN ORDER TO LAY CLAIM FOR ADDITIONAL COMPENSATION AS IMPLIED IN PARA 2A OF BONN-0023. HE STATED THAT HE INTENDED CONSULT GERMAN LAWYER AND POSSIBLY TAKE TO GERMAN COURT QUESTION AS TO WHETHER SECRECY AGREEMENT STILL BINDING UNDER GERMAN LAW. IN SUM, CURRENT CAPELAL THRUST IS CLARIFICATION LEGALITY SIGNED SECRECY AGREEMENT.

3. BASE RECOMMENDS FOLLOWING COURSE OF ACTION:
AGAIN MEET CAPELAL AND INFORM HIM THAT SECRECY AGREEMENT STILL

BINDING SINCE ACCORDING TO STATUS OF FORCES TREATY SENDING POWERS' SECRETS MUST BE PRESERVED SAME MANNER AS GERMAN STATE SECRETS. SPURGEON COULD THEN MENTION APPROPRIATE PORTION OF STATUS OF FORCES AGREEMENT TO CAPEDAL HOWEVER ANTICIPATING THAT CAPEDAL WILL NOT GIVE UP. AT THIS JUNCTURE, WE PROPOSE THEREFORE TELL HIM FURTHER DIALOGUE ON THIS MATTER USELESS AND LNHRP OBLIGED TURN TO APPROPRIATE MHRUSH AGENCY, NAMELY CAWHISPER.

4. DOUBT THAT CONFRONTATION WILL DISSUADE CAPEDAL FROM FURTHER ACTION. THEREFORE STATION SHOULD BRIEF CAWHISPER AND SOLICIT ASSISTANCE SHOULD MATTER BECOME NECESSARY. AT SAME TIME WE PLAN ALERT CATUSK THIS SITUATION IN VIEW CAPEDAL'S KNOWLEDGE WOFIRM LOCATION WHICH THEN AND NOW ENGAGED INTENSIVE LIAISON WITH CATUSK.
