1. Attached for POB is one copy of a British interrogation report on Arwed FLEGEL which was forwarded to Headquarters as an attachment to GH-1 of 3 June 1947. DIC FR 111, mentioned in Appendix A of this report, was forwarded here as an attachment to KEL-1761 of 11 February 1947. The information on FLEGEL in KEL-1761, a forty-page document, consists chiefly of a twelve-page day by day account of FLEGEL's and SPRINGER's movements between 18 February and 13 June 1946. It did not seem worthwhile to have this complete document reproduced for POB since the individuals mentioned in it are primarily the same as those listed in GH-1. Following are pertinent extracts from this document:

KEL-1761, dated 11 February 1947:

SS Ostuf, Arwed FLEGEL - camp masseur at the 6th CIC at Neuengamme in 1945-46; on 18 February 1946, escaped with Heinrich SPRINGER from this camp, and was with SPRINGER continually until 13 June 1946 when they separated and FLEGEL remained in Northern Germany; FLEGEL had helped Oberstlt. HEIN escape from the 6th CIC before he himself escaped.

2. MGB-10467 of 20 September 1950 lists one FLEGEL (fnu) as Kommandeur in the Police Surveillance Section of of SSD Potsdam, Schwannallee. We could find no other likely traces here on Arwed FLEGEL.
