Gentlemen:

This refers to the attached communication, in duplicate, from your agency concerning Frank FRUENDEL. Your file CSCI-316/00167-65.

The records of this Service show that one Frank Frungel, German nationality, born May 7, 1916, in Grauden, Deutschland, Germany, was admitted to the United States as follows:

- (1) New York, New York, on February 2, 1958, temporarily as a visitor for business. The records show that his United States address was c/o Dietrich, 210 Riverside Drive, New York, New York; his permanent address was Hamburg, Deutschland, Germany; and that he departed from the United States at Montreal Airport on February 20, 1958,
- (2) Los Angeles, California, on October 2, 1960, temporarily as a visitor for business. His United States address was the Hotel Landmark, Hollywood Boulevard, Los Angeles, California; his permanent address was Hamburg, Wittenbergenerweg 79, Germany; and that he departed from the United States at the Northeast Airlines, date not legible,
- (3) New York, New York, on October 30, 1961, temporarily as a visitor for business. His United States address was c/o O. Dietrich, 632 Warburton Avenue, Yonkers, New York; his permanent address was the same; and that he departed from the United States via P.A.A. on November 29, year not legible,
- (4) New York, New York, on November 24, 1963, temporarily as a visitor for business. His United States address was 217 Hoover Road, Yonkers, New York; his permanent address was 105 A Herwigredder Hamburg, Germany; and that he departed from the United States via KLM at New York International Airport on December 13, 1963,

(5) Los Angeles, California, on April 1, 1964, temporarily as a visitor for pleasure. His United States address was the same; his permanent address was the same; and that he departed from the United States at Boston on April 16, 1964,

(6) New York, New York, on April 18, 1964, temporarily as a visitor for business. His United States address and permanent address were the same; and that his departure destination was not legible.
