FRUENGE L IS PHYSICIST SPECIALIZING IN LASER RESEARCH, HIGH-SPEED PHOTOGRAPHY, IMPULSE (HIGH ENERGY, SHORT INTENSITY) PHYSICS, AND STROBOSCOPES. HE IS OWNER/MANAGER (ALSO REFERRED TO AS CHIEF AND SOLE LIABLE PARTNER OF) "IMPULSPHYSIK GMBH" (GMBH EQUALS "LIMITED LIABILITY COMPANY"), HAMBURG-RISEN, SUELLDORFER LANDSTRASSE 400. HE HAS (OR HAD) NUMEROUS OTHER BUSINESS CONNECTIONS, AND IS CO-AUTHOR OF TECHNICAL PUBLICATIONS. ACCORDING TO EGNA-26776, 29 JAN 65, FRUENGE L ASSUMED THE NAME PRUENGE L FOR FEAR OF REPRISALS BY THE SOVIETS AFTER HIS ESCAPE TO THE FRG (APPARENTLY FROM EAST GERMANY). FRUENGE L VISITED THE U.S. IN 1958 AND OCT 60.
