MEMO FOR RECORD

Dr. Schneider's secretary called Lukas' office to ask if we had any information on the whereabouts of Mr. Tony Brown. A call had been received by Dr. Schneider's officer from the Vier Jahreszeiten Hotel stating that they had Mr. Brown's baggage, and he had not been in the hotel for two days. Whether or not Brown's bill at the hotel has been paid was not discussed by Dr. Schneider's secretary and the caller from the hotel. She said she did not know how the Vier Jahreszeiten had obtained the telephone number of their office.

The secretary stated that she understood that Brown had intended to travel to Hannover to interview a German lady for information on the book being written by Gen Sibert. The secretary knew the lady in Hannover and had contacted her only to find that Brown had been expected there, but had not appeared. The lady in Hannover had made hotel reservations for Brown, which he did not claim.

Brown recently contacted a member of GAMMA (unidentified, but probably an individual recommended to Brown by Gen Sibert). This GAMMA member had permitted Brown to borrow some photographs and books, and was concerned that Brown had not yet returned them.

Following the above telephone conversation, Lukas' secretary checked with the OCA office who reported that he had heard nothing from Brown since the last call he received during the difficulties at the Hotel Splendid.

Lukas' secretary telephoned Dr. Schneider's secretary and advised her that we had no information which would assist in locating Mr. Brown, but that we were still trying.

After relating above information to Lukas by phone, Lukas' secretary telephoned Dr. Schneider's secretary to report that Lukas had no information on Brown at the present time. When questioned whether she knew Gen Sibert's current address, she replied in the negative and also advised that Dr. Schneider was out of the country. She said that the man

who had given books and photographs to Brown was worried that these might be in the baggage Brown had left at the hotel and would like to talk to Mr. Lukas about recovering them. She was given Lukas' home phone number, and said she would attempt to call him direct; however, she did not plan to be in her office the afternoon of 4 October. (Note: She did not reach Lukas, but above info was passed to him via his own office.)

Early afternoon, 4 Oct 68

OCA called to say that Mr. Klicks of the Hotel Splendid in Munich talked with Mr. Tom Kelly of the U.S. ConGen Visa and Citizenship Section on 4 October, and showed him a telegram received by Mr. Klick's bank from the National Bank of Martha's Vineyard, Massachusetts:

THE CHECK DRAWN ON EDWARD L. SIBERT PAYABLE TO ANTHONY BROWN IN AMOUNT OF \$440.85 REPORTED STOLEN. STOP PAYMENT HAS BEEN PLACED.

Mr. Kelly reiterated to Mr. Klicks that the U.S. ConGen was merely attempting, unofficially, to assist Gen Sibert. Mr. Kelly assured Mr. Klicks that he would try to pass the information about the stop-payment order on to Gen Sibert and assured Mr. Klicks that it was not Gen Sibert's intention that Mr. Klicks would lose money owed to him.

The OCA Representative telephoned the Vier Jahreszeiten Hotel and inquired for Mr. Brown. The hotel informed him that Mr. Brown had checked out two days ago.
