FOLL IMPRESSIONS GAINED UPON REVIEWING DRAFT OF SPIEGEL MANUSCRIPT:

1. NINE SECTIONS OF MANUSCRIPT A CURIOUS COLLAGE. PROLIX, RAMBLING IN STYLE, UNEVEN IN SUBSTANCE. OPENS WITH EXTRAVAGANT CLAIMS OF CATRIBE SUCCESSES--PREDICTING TO THE HOUR THE 1967 NE WAR, ANTICIPATING BY FOUR WEEKS THE INVASION OF CZECHOSLOVAKIA. LAUDS JAS STERN MENTOR OF CATRIBE AND ; LATTER DEPICTED AS SUPINE AND HELPLESS.

2. BULK OF MANUSCRIPT GIVES A MIXED YET OVERALL FAVORABLE AND ROMANTICIZED DEPICTION OF UTILITY AND HIS WAR-TIME AND POST-WAR CAREER. PARTICULAR EMPHASIS GIVEN TO HOW UTILITY BEGUILLED AMERICANS INTO SPONSORING HIS ORG. RHAPSODIZES GENERAL SIBERT AS TRUE VISIONARY WHO WENT TO BAT FOR UTILITY COUNTER TO ORDERS SUPERIOR HQS. SECTION FIVE CULMINATES IN STATEMENT THAT AMERICANS SO ENAMORED OF UTILITY'S MODEL OF AN INTEL ORG WHICH BOTH COLLECTS AND EVALUATES INFO

THAT THEY PATTERED JKLANCE ON UTILITY CREATION. ACCORDING TO MS, BRITISH, FRENCH AND SWISS EQUALLY ENAMORED. FROM RATHER EXTRAVAGANT PRAISE OF UTILITY, MS MOVES TO CRITICISM OF HIS HIRING NUMEROUS FORMER SD AND SS PERSONNEL AND CREATING AN ANTI-COMMUNIST SPITZELAPPARAT IN FEDREP. IMPLICATION THAT THIS AMERICAN INSPIRED. MENTIONS CATRIBE BLACK LIST CONTAINING SPITZEL REPORTS ON RED RUDI AUGSTEIN, SPD CHMN ERICH OLLENHAUER, HERBERT WEHNER AND GUSTAV HEINEMANN. MS CITES CATRIBE FRIENDS STATING ANTI-COMMUNIST PSYCHOSIS ENDED MID-50'S BUT JUXTAPOSES THIS WITH QUOTES FROM WITCH-HUNTING SPITZEL REPORTS OF 1963 VINTAGE.

3. SECTION NINE CITES EXAMPLES OF CATRIBE PENETRATIONS OF DDR GOVT AND SOVIET INSTALLATIONS. RELATES UTILITY'S OPERATION AGAINST WOLLWEBER. CITES THE GROTEWOHL SECRETARY OPERATION. STATES CHIEF INTERPRETER IN EAST BERLIN SOVIET EMBASSY WAS CATRIBE AGENT AND RELATES THAT UTILITY HAD ACCESS AGENT WORKING ON SEMENOV. SECTION NINE MENTIONS ONE DR. CAROL TARMAY AS BEING JKLANCE.

4. SECTION NINE ENDS AIMLESSLY, GIVING RISE TO CONCLUSION THAT MORE IS TO COME. SPECULATE THAT MIXED BUT
