1, KEY POINTS IN DECISION WHETHER ATTEMPT SCREEN AND COPY MICROFILM MATERIAL ARE CLEARLY:

A. DEGREE OF RISK IN ASKING L J PROVIDE BKHERALD ACCESS TO MATERIAL. SPECIFICALLY, CAN WE COUNT ON L J FULL COOPERATION AND DISCRETION, DOES L J SCHEDULE FOR PICK-UP AND DEPOSIT OF FILM PERMIT SUFFICIENT TIME FOR COPYING TASK. COULD OR WOULD UTILITY ATTEMPT CHECK ELAPSED TIME AND THEREBY L J TRUSTWORTHINESS.

B. NATURE AND VALUE TO BKHERALD OF MATERIALS IN QUESTION,
