2. SEVERAL MONTHS AGO [] RETURNED THIS EQUIPMENT TO THE BASE, STATING THAT GEHLEN HAD CONTACTED HIM AND ASKED HIM TO TURN IT IN.

3. ABOVE IS ALL WE KNOW OF GEHLEN'S MICROFILMING ACTIVITIES. WE STRONGLY RECOMMEND THAT WE NOT GET INVOLVED IN ATTEMPT TO GAIN ACCESS TO GEHLEN'S FILES VIA [] THEY CERTAINLY HAVE NO CURRENT OPERATIONAL VALUE TO CIA,
