1. SOURCE PAID BRIEF COURTESY CALL ON UTILITY AFTERNOON OF 26 DEC. SOURCE EXPLAINED ALL MATERIALS SAFE IN BANK DEPOSIT BOX, BUT TO MAKE THEM FIT BOX HE HAD TO BREAK LARGE PACKAGE DOWN INTO THREE SMALLER ONES. UTILITY SAID THIS FINE, ASKED SOURCE TAKE GOOD CARE OF FILES AS THEY "ENTIRE FILES" OF STRATEGIC SERVICE.

2. UTILITY SAID ONCE THINGS QUIET DOWN HE WOULD LIKE HAVE SOURCE ARRANGE THAT FRL. KUNZE ALSO HAS ACCESS TO DEPOSIT BOX BUT IT NOT SAFE TO DO THIS YET. UTILITY CLAIMED ONLY REASON HE WANTED KUNZE TO HAVE ACCESS WAS SO SOMEONE COULD RETRIEVE MATERIALS IN EVENT SOMETHING SHOULD HAPPEN TO SOURCE.

3. UTILITY SPENT MOST OF SHORT MEETING TALKING ABOUT BOOK ON CASCOPE OPS WHICH HE WOULD LIKE TO BRING OUT. HIS PAST BOOKS COVERED HISTORY BUT NOW HE WANTS TO COVER OPS SUCCESSES AND ASKED SOURCE TO COLLABORATE WITH HIM. UTILITY PROMISED TO PROVIDE NECESSARY BACKGROUND MATERIAL BUT WANTED SOURCE TO DO MOST OF
