1. *[ ]* (IDEN A, *[ ]* ONLY) ON-AGAIN, OFF-AGAIN TRIP TO BEIRUT IS ON AGAIN, THIS TIME FOR PERIOD 6-9 DEC. THE PFLP EMISSARY CITED REF (WHO ACCORDING INFISHY/2 IS HABBASH DEPUTY AND WAS SUPPOSED TO HAVE MET WITH *[ ]* DURING EUROPEAN VISIT MID-NOV) NEVER SHOWED. INFISHY/2 (IDEN B) THEN WENT BEIRUT THIRD WEEK NOV. ON RETURN GENEVA, I/2 TOLD *[ ]* THAT PFLP WORRIED ABOUT POSSIBLE SECURITY CHECKS AT EUROPEAN BORDERS/AIRPORTS, SO CANCELLED TRIP.

2. I/2 SAID THAT PFLP NUMBER TWO MAN STILL WISHED MEET WITH *[ ]* AND HAD DECIDED RISK MEETING IN BEIRUT. I/2 ADDED PFLP WOULD TAKE APPROPRIATE PRECATUIONS TO PRESERVE SECURITY AND THAT HE (I/2) WOULD SIT IN ON MEETING.

3. I/2 DEPARTS 3 DEC FOR LIBYA AND YEMEN AND SCHEDULED ARRIVE BEIRUT 6 DEC. I/2 REQUESTED *[ ]* ALSO ARRIVE BIERUT 6TH AND AFTER CHECKING INTO HOTEL PHONECIA TO CALL HIM FOR FURTHER
