IN MONITORING KHASHOGGI MOVEMENTS AND PLANS IN ORDER NEUTRALIZE KHASHOGGI AND, IF POSSIBLE, ELIMINATE HIM. I/2 ASKED [ ] IF HE WOULD BE WILLING TRAVEL TRIPOLI TO REPORT DIRECTLY TO LIBYANS ON KHASHOGGI PLANS TO PURCHASE CONTROLLING INTEREST CERTAIN SEYCHELLES HOTELS AND SCHEDULED MEETING WITH SYECHELLES CHIEF MINISTER JAMES MANCHAM, WHICH [ ] HAD ARRANGED FOR FIRST WEEK MARCH. [ ] AGREED. 4. I/2 REQUESTED [ ] TO STANDBY FOR TRAVEL TO TRIPOLI ON SHORT NOTICE DURING COMING WEEKEND. [ ] SOMEWHAT APPREHENSIVE RE PROVIDING INFO ON KHASHOGGI WITH WHOM HE BECOMING MORE CLOSELY AFFILIATED AND WISHED MAINTAIN CONNECTION. I/2 ASSURED [ ] THAT AT THIS STAGE, LIBYANS MERELY WISHED EXPLORE WAYS MEANS COUNTERING KHASHOGGI BY OUT-MANEUVERING HIM FINANCIALLY. I/2 ADDED THAT ALTHOUGH KHASHOGGI REMAINED A TARGET FOR LIBYAN-

7. [ ] FELT HE WOULD HAVE MORE POSITIVE INFO UPON RETURN FROM TRIPOLI AND/OR BAGHDAD/BEIRUT TRAVEL, IF AND WHEN IT MATERIALIZED. HOWEVER, WILL BE ON TIGHT SCHEDULE DURING WEEK OF 16 FEB SINCE MUST COMPLETE SURVEY REPORT FOR KHASHOGGI'S GENEVA REP (GERARD B O I S S I E R) AND RETURN TO SEYCHELLES WELL IN ADVANCE OF KHASHOGGI'S ARRIVAL. THUS HE UNCERTAIN WHETHER WILL BE ABLE TRAVEL FRANKFURT FOR DEBRIEFING.
