E. LETTER TO INFISHY/2, ENCLÖSING COPIES OF B., C., AND D., ABOVE, SUMMARIZING STATUS AND REQUIREMENTS OF AVIATION AND TRAINING SCHOOL PROJECTS. THIS LETTER, WRITTEN AT I/2'S REQUEST IN ENGLISH SO IT COULD BE TURNED OVER READILY TO LIBYANS, NOT^{ES} THAT INITIAL INVESTMENT REQUIRED WOULD BE APPROX 1.5 MILLION SWISS FRANCS AND THAT KHASHOGGI GROUPS PLANS SECOND VISIT TO SEYCHELLES MID-APRIL TO MAKE DECISIONS ON DEVELOPMENT PROPOSALS; SO, IF I/2'S LIBYAN FRIENDS ARE INTERESTED IN BUYING INTO PROJECTS, WOULD HAVE TO ACT FAST.

3. [] MET WITH I/2 AFTERNOON 13 MAR TO GIVE LATTER DOCUMENT E, ABOVE, AND ATTACHEMENTS. I/2 SAID HE WOULD PASS THESE TO AL H U N I VIA A SPECIAL CONTACT IN PARIS WHOM HE WOULD MEET 15 MAR. I/2 THEN SAID HE HAD BEEN GIVEN SPECIAL MISSION BY LIBYANS TO MAKE CONTACT WITH AND ASSESS UNNAMED "REVOLUTIONARY GROUPS" IN VENEZUELA, AND W^OULD PROCEED CARACAS FROM PARIS LATER ON 15TH. I/2 SAID HE EXPECTED REMAIN VENEZUELA APPROX TWO WEEKS. IF, DURING HIS ABSENCE, LIBYANS

NEEDED ADDITIONAL DETAILS, THEY WOULD CONTACT I/1 DIRECTLY TO REQUEST HE VISIT TRIPOLI. I/2 DID NOT ELABORATE ON HOW [] WOULD BE CONTACTED. [] WILL ATTEMPT FIND THIS OUT PRIOR I/2'S DEPARTURE FOR PARIS AND CARACAS.

4. I/2 SAID THAT HE HAD UNSUCCESSFULLY ATTEMPTED SEE AL HUNI IN EARLY MARCH, WHEN LATTER HAD BEEN IN PARIS "UNOFFICIALLY". HOWEVER, HAD RECEIVED WORD, ALSO VIA HIS SPECIAL PARIS CONTACT, THAT AL HUNI VERY INTERESTED IN SEYCHELLES PROPOSALS FOR BOTH STRATEGIC AND POLITICAL REASONS, AND WANTED STUDY [] INFORMATION CLOSELY. [] ASSUMES I/2 RECEIVED INSTRUCTIONS FOR VENEZUELAN MISSION ALSO FROM PARIS CONTACT.

5. FROM WHAT [] CAN GATHER, I/2'S RELATIONSHIP WITH AL HUNI STEMS FROM EARLY 1960'S WHEN BOTH IN ALGERIA. AL HUNI APPEARS BE ONLY HIGH RANKING LIBYAN WITH WHOM I/2 IN REGULAR CONTACT. WHEN I/2 FIRST DISCLOSED AL HUNI NAME TO [] HE ADDED THAT ALTHOUGH AL HUNI HAD RECENTLY BECOME FOREIGN MINISTER, HE STILL RETAINED RESPONSIBILITY FOR INTELLIGENCE AND POLITICAL SECURITY.
