A. INFISHY/2 (I/2) REMAINS KEENLY INTERESTED IN MONITORING MOVEMENTS/FINANCIAL PLANS OF KHASHOGGI IN BEHALF BOTH PFLP AND LIBYANS. I/2 HAS MADE CLEAR HIS OWN ACTIVITIES FOR PFLP AND LIBYANS ARE COMPLETELY SEPARATE OPERATIONS, ALTHOUGH EACH SPONSOR AWARE I/2 INVOLVED WITH THE OTHER, FOR DIFFERENT PURPOSES. PFLP IS ACTION-ORIENTED, HAS SHIFTED MOST OF OPERATIONS CENTER TO IRAQ WHERE POLITICAL ATMOSPHERE APPARENTLY MORE FRIENDLY. I/2'S ONLY SUBSTANTIVE CONTACT IN LIBYA IS AL-HUNI WHO HAS PROMISED I/2 HELP IN OBTAINING "POLITICAL MONEY" TO COUNTER ISRAELI AND ANTI-LIBYAN ARAB ECONOMIC INTERESTS, E.G., KHASHOGGI

B. ACCORDING I/2, PFLP NOW INTERESTED IN "CAPTURING" KHASHOGGI AND HAS WORKED OUT DEAL WITH KUWAITIS TO HOLD KHASHOGGI AND TURN HIM OVER TO PFLP FOR QUESTIONING, SHOULD KHASHOGGI LAND IN KUWAIT. DEAL WOULD REQUIRE MINIMUM FIVE DAYS ADVANCE NOTICE, HOWEVER, FOR PFLP TO MAKE APPROPRIATE ARRANGEMENTS WITH KUWAITI SUPPORT ELEMENTS. THIS ANOTHER REASON WHY I/2 ENCOURAGING [ ] TO INSINUATE SELF WITH TRIAD GROUP, PARTICULARLY WITH TRIAD GENEVA REP BOISSIERE, IN HOPES OBTAINING ADVANCE INFO ON KHASHOGGI PLANS TO FLY INTO KUWAIT.

C. I/2'S "SPECIAL CONTACT" IN PARIS (PARA 4 REF) WAS LIBYAN AMBASSADOR WHO IN PROCESS TRANSFERRING TO MADRID. FROM I/2'S RECENT REMARKS, HOWEVER, [ ] GATHERS THIS CONTACT USED SOLELY TO REACH AL HUNI AND WAS NOT IN FACT RESPONSIBLE FOR I/2'S LATIN AMERICAN MISSION. I/2 CONTINUES VAGUE RE SPONSOR AND REAL PURPOSE OF HIS LATIN AMERICAN TRIP, DURING WHICH HE COVERED SEVERAL COUNTRIES IN ADDITION VENEZUELA.

D. I/2 HAS AGAIN ASKED [ ] TO STAND-BY FOR POSSIBLE TRIP TO TRIPOLI, TO BRIEF AL HUNI ON KHASHOGGI INVESTMENT IN SEYCHELLES. I/2 HAS SPENT LAST SEVERAL DAYS ON PHONE ATTEMPTING GET THROUGH TO AL HUNI, BUT HAD NOT SUCCEEDED AS OF 11 JUNE.

[ ] AND [ ] REVIEWED EXISTING OPS REQUIREMENTS WITH [ ] AND INSTRUCTED HIM ADOPT MORE AGGRESSIVE TACTICS IN PUSHING I/2 FOR NAMES AND DETAILS, PARTICULARLY IN THOSE AREAS IN WHICH I/2 WANTS [ ] COOPERATION. [ ] CONCURRED, ADMITTED HE HAD BEEN PERHAPS OVERLY-CAUTIOUS AT OUTSET OF OP BUT RECOGNIZED NEED TO PIN DOWN SPECIFICS OF I/2'S ACTIVITIES. [ ] ALSO NOTED HIS RELATIONSHIP WITH I/2 ON MORE SOLID BASES THAN YEAR AGO AND THAT HE HIMSELF HAD MORE CONFIDENCE IN HIS ABILITY ELICIT INFO, AS RESULT BKHERALD DIRECTION. ALL AGREED OP HAS LITTLE TO LOSE BY [ ] MORE AGGRESSIVE, QUESTIONING POSTURE, IN VIEW PAUCITY HARD INFO REVEALED BY I/2 THUS FAR.

3. IN PHONE CALL TO [ ] 11 JUNE, [ ] ADVISED HE HAD MET I/2 ON 10TH AND HAD SPECIFICALLY ASKED IF IDEA OF CAPTURING KHASHOGGI ORIGINATED WITH I/2. LATTER REPLIED NOT AT ALL, THAT PFLP LEADERS HAD PROPOSED THIS DURING I/2'S LAST MEETING WITH THEM IN IRAQ, THAT PLAN, INCLUDING KUWAITI COOPERATION, AND BEEN SERIOUSLY DISCUSSED AND THAT I/2 INVOLVED PRINCIPALLY BECAUSE HE HAD SOURCE [ ] WHO ON VERGE "PENETRATING" KHASHOGGI ORGANIZATION AND WHO MIGHT PROVIDE NEEDED ADVANCE INFO ON KHASHOGGI MOVEMENTS.
