RE QUERY POSED PARA 4 REF, AFTER READING OF INFOISHY/2'S (I/2) HQS FILE, THERE SOME INTERESTING ELEMENTS WHICH, WHILE FAR FROM CONCLUSIVE, MIGHT INDICATE POSSIBLE LINK BETWEEN I/2 AND THE CURIEL APPARAT EVEN THOUGH CURIEL HAS TENDED STAY ALOOF FROM VIOLENT FEDAYEEN TYPE ACTIVITIES WHICH I/2 APPARENTLY INVOLVED AT PRESENT.

2. FIRSTLY, I/2 APPARENTLY ONE OF NUMEROUS EUROPEAN FLN SUPPORTERS TO WHOM BEN BELLA OFFERED HOSPITALITY AND JOBS IN IMMEDIATE ALGERIAN POST-INDEPENDENCE DAYS. CURIEL WAS ANOTHER; HENCE, THEY WERE IN ALGIERS TOGETHER, BOTH AS ADVISORS TO ALGERIAN GOVT (ALONG WITH NUMEROUS OTHER EUROPEANS). SECONDLY, AT BEST A LONG SHOT CONNECTION, IN OCT 1960, CURIEL'S WIFE, ROSETTA, WAS ARRESTED IN GENEVA ON SUSPICION OF ILLEGAL FINANCIAL TRANSACTIONS ON BEHALF OF FLN. SWISS AUTHORITIES DETERMINED SHE WAS HOLDER OF RECORD OF AN ACCOUNT IN AMOUNT OF \$150,000 AT SWISS BANKING CORP. SWISS WERE QUITE CERTAIN THIS WAS FLN MONEY USED TO SUBSIDIZE CURIEL'S FLN SUPPORT

NETWORK. FRENCH POLICE REPORT (ATTACHMENT TO OFLA-3489, 21 FEB 66) STATED THAT IN 1960, I/2 WAS "INVOLVED IN SWITZERLAND IN THE MANAGEMENT OF FUNDS AND PROPERTY BELONGING TO THE THREE 'NATIONAL LIBERATION ARMIES' OF TUNISIA, MOROCCO AND ALGERIA. IT WAS HE WHO PERFECTED AND REALIZED THE SYSTEM OF NUMBERED ACCOUNTS WITH MULTIPLE AND SIMULTANEOUS SIGNATURES."

3. ON THE OTHER HAND, IT IS DIFFICULT TO IMAGINE ^{CURIEL} KNOWINGLY COLLABORATING WITH AN INDIVIDUAL AS WIDELY KNOWN FOR FASCIST ASSOCIATIONS AS IS I/2.4

SUGGEST [], IF HIS RELATIONSHIP WITH [] AND IF [] RELATIONSHIP WITH I/2 CAN BEAR IT, ATTEMPT HAVE IN SOME MANNER [] BRING UP CURIEL'S NAME WITH I/2, IF NOT IN EXPLICIT TERMS, THEN MAKE REFERENCE TO A PARISIAN GROUP WHICH SUPPORTS NATIONAL LIBERATION MOVEMENTS AND WHOSE LEADER IS AN EGYPTIAN COMMUNIST (CURIEL APPARAT).
