EVENING 2 OCTOBER [ ] RECOUNTED RECENT RATHER BIZARRE ENCOUNTER HE HAD WITH STAFF MEMBER BEAU RIVAGE HOTEL LAUSANNE NAMED "ALBERTO" WHO CLAIMED BE MEMBER ITALIAN BRANCH OF "ORDRE NOUVEAU" AND WHO HAD FLED ITALY AFTER PARTICIPATING IN KIDNAPPING MILAN POLICE CHIEF, ALBERTO CLAIMED BE ESTEEMED CLANDESTINE OPERATOR OF "ORDRE NOUVEAU" WHO HAD BEEN DEEPLY INVOLVED WITH GREEK COLONELS, AND SAID HE AWARE THAT HIS ORGANIZATION HAD RECENTLY PETITIONED LIBYAN AMBASSADOR MADRID AL HUNI FOR FINANCIAL SUPPORT. AFTER COMMUNICATING WITH TRIPOLI, AL HUNI TOLD ORGANIZATION REP HE FELT REQUEST WOULD BE SYMPATHETICALLY CONSIDERED, BUT ASKED FOR COMPLETE DOSSIER ON ORGANIZATION AND ITS ACTION PLAN.
