1. [] NOTES THAT ONLY TIME FRANCOIS ((GENOUD)) HAS COME UP ON THEIR SCREEN OVER THE PAST SEVEN YEARS WAS IN 1979 WHEN A FRIENDLY SERVICE REPORTED THAT GENOUD WAS IN IRAQ WITH BRUNO ((BREGUET)). [] WERE NEVER ABLE TO CONFIRM REPORT. THEY DO NOTE THAT THEY HAVE REPORTS DEALING WITH GENOUD WHICH DATE BACK TO NAZI TIMES, BUT THAT OF LATE, HE HAS KEPT A LOW PROFILE.

2. [] MEMO NOTES THAT IN RESPONSE TO THE "LE MONDE" ARTICLE OF 8 MARCH 82, THE LAUSANNE PAPER "TRIBUNE - LEMATIN" INTERVIEWED GENOUD ON 12 MARCH 82. THE ARTICLE CLAIMS THAT GENOUD EMPHATICALLY DENIED ALLEGATIONS MADE IN "LE MONDE". [] MEMO STATES THAT THEY HAVE NO WAY OF CONFIRMING OR DENYING "LE MONDE" ALLEGATIONS. HOWEVER, [] PRIVATELY TOLD DCDB THAT THERE WAS LITTLE DOUBT THAT "LE MONDE" ARTICLE REPRESENTED GENOUD'S REAL ACTIVITIES.
