2. VISAS DONKEY

3. MR. FRANCOIS GENOUD (DPOB: 26 OCTOBER, 1915, LAUSANNE) HAS AGAIN REQUESTED A VISITOR'S VISA TO THE UNITED STATES. HE APPEARS IN VLOS UNDER CODE DEPT. 26 AND THE REFUSAL FILE AT POST SHOWS HE HAS BEEN FOUND INELIGIBLE TO RECEIVE A VISA UNDER SECTION 212(A)(28)(F) OF THE INA.

4. REASON FOR PRESENT TRAVEL IS TO SPEND TWO WEEKS IN NEW YORK CONSULTING WITH LAWYERS ON POSSIBILITIES FOR FILING A SUIT AGAINST PUTNAM INC. PUBLISHERS, WHOM HE CLAIMS HAVE VIOLATED HIS COPYRIGHTS IN CONNECTION WITH THE PUBLICATION OF THE DIARY OF JOSEPH GOEBBELS. HE SAYS CERTAIN DOCUMENTS BELONGING TO HIM WERE OBTAINED BY PUTNAM INC. ILLEGALLY THROUGH A BRITISH PUBLISHING HOUSE. MR. GENOUD HAS NOT YET SELECTED A PARTICULAR LAWYER, RATHER HE WOULD LIKE TO MEET WITH SEVERAL BEFORE DECIDING.

5. INFORMATION DEVELOPED AT THE TIME OF THE 212(A)(28)(F) FINDING OF INELIGIBILITY INDICATES MR. GENOUD MAY ALSO NOW BE INELIGIBLE UNDER SECTION 212(A)(33) OF THE ACT, GIVEN HIS NAZI CONNECTIONS. DEPARTMENT MAY WISH TO PURSUE THIS ASPECT OF THE CASE AT THIS POINT. LODGE
