1. IDENTITY A (SUBJECT) TRAVELLED TO LAUSANNE AS SCHEDULED AND MET FOR ALMOST 4 HOURS WITH JWFISHY/2 (F/2). WE REVIEWED THE NOTES SUBJECT KEPT FROM THE MEETING BUT FOUND NOTHING OF INTELLIGENC INTEREST.

2. F/2 SUBSEQUENTLY CAME UP TO PARIS AND CALLED ON SUBJECT. THIS SECOND MEETING PRODUCED LITTLE MORE OF VALUE SAVE CONFIRMING THAT F/2 LIKES TO TALK IN HUGE ROUND TERMS ABOUT HIMSELF, HIS IMPRESSION OF INFLUENCE, AND HIS PARTICULAR PHILOSOPHY. HE SAID, FOR INSTANCE, THAT HE WAS MOVING LIBYAN FUNDS TO THE IRA BUT WOULD PROVIDE NO SPECIFICS.

3. SUBJECT SAID THAT F/2 AGREED TO TALK TO HER ONLY IF WHAT HE SAID WAS NOT PRINTED. DURING THE SECOND MEETING, SUBJECT SAID SHE COULD NOT, AS A PROFESSIONAL JOURNALIST, WORK UNDER SUCH A RESTRICTION AND THEN COMMENTED THAT HE HAD TOLD HER VERY LITTLE WHICH WOULD BE USEFUL ANYWAY. F/2 FEIGNED TO BE INJURED BUT COULD NOT BE PERSUADED TO SUPPORT ANY OF HIS SWEEPING STATEMENTS. SUBJECT BELIEVES F/2 COULD BE UNBALANCED OR SENILE. EITHER WAY, SHE WILL NOT SEE F/2 AGAIN.

4. ON 5 MAY 1986, SUBJECT WAS INTRODUCED OVER LUNCH TO THE LIBYAN AMBASSADOR IN PARIS. THE LATTER SAID HE WAS DISAPPOINTED THAT HE HAD NOT BEEN ABLE TO MEET WITH THE U.S. AMBASSADOR IN PARIS, ADDING THAT COLONEL QADHAFI WAS READY TO MEET THE U.S. PRESIDENT AT ANY TIME. SUBJECT, MEANWHILE, WAS ANGLING TO GET A PRIVATE INTERVIEW WITH QADHAFI FOR HERSELF. WE POLITELY DECLINED HER OFFER TO INTRODUCE US TO THE LIBYAN.

5. WE BRIEFED SUBJECT ON THE TRAVEL RESTRICTION TO LIBYA.

6. SUBJECT KNOWS THAT HER STATUS DOES NOT PERMIT US TO DIRECT HER IN ANY WAY. SHE SEEMS TO UNDERSTAND WHAT MIGHT BE OF SPECIAL INTEREST TO PNREADY AND WILL CALL THE STATION IF ANYTHING OF NOTE OR VALUE COMES TO HER ATTENTION.
