1. ACTION REQUESTED: TRACES AND COMMENTS ON ((GENOIT)).

2. C/LNCOLLAR ADVISED [] ON 14 SEPT THAT HIS CYPRIOT COUNTERPARTS HAD INFORMED HIM THAT ONE FRANCOIS ((GENOIT)), A SWISS CITIZEN AND ALLEGEDLY A MEMBER OF THE PFLP, HAD BEEN IN CYPRUS RECENTLY AND MET WITH KHALID HASSAN ((MOUEIMNE)) OR ((MU'AYMAY)), A PROMINENT LEBANESE BUSINESSMAN WHO RESIDES IN LIMASSOL. MOUEIMNE IS WELL KNOWN TO C/LNCOLLAR, WHO IS TRYING TO ENLIST HIS ASSISTANCE AS A SOURCE. HE WILL TRY TO FOLLOW UP FURTHER WITH THE GENOIT STORY. WE HAVE NO LOCAL TRACES ON GENOIT, ALTHOUGH WE RECALL THAT HIS NAME MAY HAVE BEEN MENTIONED BY BRUSSELS WALKIN/[] SOURCE ANDRE ((BENAYER)). PLEASE TRACE AND ADVISE.
