TEXT:

1. ACTION REQUIRED: FOR HEADQUARTERS. PLEASE INCORPORATE ALI AL ((RAHBAR)) INTO LIAISON MEMO. [] IS THERE ANYTHING WE CAN TELL THE SWISS ABOUT AHMED ((RAMI))?

2. FOR [] HEADQUARTERS IS DRAFTING A DELICATE MEMO TO THE SWISS FEDERAL POLICE (BUPO) CONCERNING [] THE OBJECTIVE IS TO CONVINCe BUPO THAT THEY ARE BEING KEPT WELL INFORMED ABOUT THE CASE WITHOUT STIMULATING THEIR INTEREST IN IT. BUPO UNFORTUNATELY HOPES THAT [] WILL BE ABLE TO SHED LIGHT ON THE JWFISHY/2 (F/2) BOMBING THAT TOOK PLACE IN EARLY OCTOBER 1993. WE HAVE INFORMALLY ADVISED THEM ALREADY THAT [] WAS UNABLE TO LEARN ANYTHING FROM F/2 ABOUT THE INCIDENT (TRUE), BUT BUPO IS STILL HOPEFUL, AND CONTINUES TO REQUEST A WRITTEN UP-DATE ON THE STATUS OF THIS CASE. IF [] CAN SHED ANY LIGHT ON THE ACTIVITIES OF AHMED ((RAMI)) (REF C) THAT HEADQUARTERS CAN INCORPORATE INTO THE MEMO IT IS DRAFTING FOR LIAISON, THIS WOULD BE APPRECIATED.

3. FOR HEADQUARTERS: THE NAME THAT BUPO CHIEF OF COUNTER TERRORISM GAVE TO C/O IN POSSIBLE CONNECTION WITH THE F/2 BOMBING IS ALI AL RAHBAR, FOUND IN PARA 3 OF REF B. THOUGH WE SUPPOSE THERE IS NO INFORMATION ABOUT THIS PERSON IN OUR FILES, MENTIONING HIM IN THE MEMO WOULD HELP SATISFY BUPO THAT WE HAVE METICULOUSLY EXAMINED THEIR REQUEST AND PURSUED THE LEAD AS FAR AS POSSIBLE. PLEASE NOTE THAT OTHER SUSPECT NAMES CONNECTED WITH THE F/2 BOMBING WERE BROUGHT TO OUR ATTENTION IN REF D, BUT BECAUSE THIS WAS AN "OFF THE RECORD" CONVERSATION WITH A BUPO OFFICER, ANY INFORMATION ABOUT THESE INDIVIDUALS CANNOT BE INCLUDED IN THE MEMO.

4. FOR CTC/RPB: WE APPRECIATE REF A UPDATE ON THE STATUS OF THE PAPER FOR BUPO. SHOULD THIS ISSUE ARISE DURING [] MARCH DISCUSSION WITH BUPO C/CT OR C/BUPO, WE WILL ADVISE THEM THAT WE EXPECT THE MEMO BY 14 MARCH.
