1. [ ] AND [ ] MET WITH GLOBKE ON 8 APRIL AT LATTER'S REQUEST TO DISCUSS HIS APPREHENSION REGARDING FUTURE OF G.I.S. APPREHENSIONS BASED ON ALLIED REFUSAL TO USE PHRASE "GERMAN INTELLIGENCE SERVICE" IN SECRET INTELLIGENCE PROTOCOL ANNEXED TO CONTRACTUAL AGREEMENT AND ALLIED-GERMAN DEBATE OVER REVISION PERIOD FOR PROTOCOL.
2. DISCUSSION DEVELOPED IN SUCH A MANNER THAT NEED BEING APPARENT TO ASSURE GLOBKE ALLIED REFUSAL TO USE G.I.S. TERM BASED ON "GOVERNMENT AGREEMENTS" WHICH WOULD HAVE NO FORCE AFTER CONTRACTS RATIFIED. THIS EXPLANATION, PLUS ASSURANCES WE WERE STILL INTENSELY INTERESTED IN BRINGING ZIPPER INTO UPGROWTH, ALLAYED GLOBKE'S FEARS.
3. TODAY THREE HICOMERS AND UPTHURST REACHED AGREEMENT ON ALL DISPUTED POINTS ON PROTOCOL EXCEPT MONITORING, FOR WHICH NO TRIPARTITE AGREEMENT YET EXISTS. WE DISCUSSED AGREED PROTOCOL WITH GLOBKE 9 APRIL. HE DECLARED HIMSELF ENTIRELY SATISFIED. ALSO DISCUSSED U.S. PROPOSAL FOR SOLVING MONITORING PROBLEM TO WHICH GLOBKE AGREED IN PRINCIPLE.
4. WE WILL ATTEMPT NEXT WEEK TO SECURE BRITISH AND FRENCH ACCEPTANCE OF PROPOSAL, ON GROUNDS OF MODIFICATIONS NOT YET SEE BY THEM. THIS WILL ENTAIL FIRST GETTING MCCLOY OR REBER PERMISSION, SINCE MONITORING STILL TECHNICALLY AT HIGH COMMISSION LEVEL. ALTHOUGH CHANGE OF REACHING TRIPARTITE AGREEMENT THERE SLIM, ANY WELL BE ACCOMPLISHABLE HOWEVER AT LEVEL OF INTELLIGENCE NEGOTIATORS.
