GLOBKE'S COMMENTS RE ZIPPER LEGALIZATION RECEIVED 15 JUL:

1. ALL PARTICIPANTS MEETING REPORTED BONN 1648 (IN27177)
AGREED EARLY LEGALIZATION ZIPPER AS GIS AND SEPARATION FROM BFV.
2. SCHAEFFER OBJECTED TO HIGH COSTS OF PROPOSED OPERATION
BUT AFTER SOME HAGGLING AGREED PROVIDE SUFFICIENT FUNDS FOR SECOND
HALF GERMAN FISCAL YEAR STARTING 1 OCT. IN CASE LEGALIZATION IN
EFFECT BY THEN. HALF OF UTILITY 26 MILLION ESTIMATE WOULD BE 13
MILLION; SCHAEFFER ATTEMPTED TO FIX HALF-YEAR FIGURE AT 10 MILLION
BUT WAS PERSUADED TO SHOOT FOR 15. IT IS INTENDED THAT THE BUDGET
FIGURE WILL BE SHOWN ONLY AS ONE LUMP SUM WITH NO PUBLISHED DETAILS.
APPROVAL MUST BE OBTAINED FROM HAUSHALTS KOMITEE (APPROPRIATIONS)
FOR THE LUMP SUM BUDGET PRESENTATION AND FOR A LIMITED ACCOUNTING
PROCEDURE BUT GLOBKE FORESEES NO DIFFICULTY OBTAINING THIS APPROVAL.
SCHAEFFER AGREED TO HAVE FED ACCOUNTANT PERMANENTLY ASSIGNED TO
PULLACH TO CERTIFY EXPENDITURES AND REPORT ONLY TO PRESIDENT OF

3. ALL AGREED TO HAVE SOME KIND OF BOARD SIMILAR TO OUR NSC WHICH WOULD GUIDE POLICY AND OPERATIONS. THE GIS WOULD BE ADMINISTRATIVELY UNDER CHANCELLERY BUT WOULD REPORT TO AND BE DIRECTED BY THE BOARD MADE UP OF CABINET MINISTERS. WORKING WITH THE BOARD WOULD BE A PARLIAMENTARY COMMITTEE OF SELECTED AND CLEARED MEMBERS OF BOTH GOVT AND OPPOSITION WHO WOULD BE KEPT GENERALLY INFORMED OF GIS ACTIVITIES AND WOULD BE COUNTED ON TO FIGHT ITS CAUSES AND ITS BUDGET BOTH IN THE BUNDESTAG AND WITHIN THEIR FRAKTIONS. THE DETAILS OF THIS ORGANIZATIONAL SCHEME NOT YET COMPLETE AND STAFF WORK BEING DONE BY GUMBEL OF BUNDESKANZLERAMT. GUMBEL USING L 1 BRIEFING PAPER AS BASIC GUIDE.

4. THERE WAS GENERAL AGREEMENT TO LEGALIZATION AND PROPOSED TYPE OF CONTROL EXCEPT INCIDENTAL ATTEMPT OF SCHROEDER TO RECOMMEND INTERIOR MINISTRY CONTROL OF GIS. GLOBKE ATTRIBUTES THIS NOT TO HIS INTERIOR POSITION BUT TO HIS LONG RANGE AMBITION TO BECOME FOREIGN MINISTER.

5. BONN COMMENT: WE INFORMED GLOBKE THAT WE DID NOT WISH INTERFERE THEIR INTERNAL AFFAIRS BUT CERTAINLY THOUGHT THESE DEVELOPMENTS SEEMED SOUND AND REFLECTED OUR CONVICTION RE NECESSITY OF AN INTEGRATED SERVICE WITH EXECUTIVE DIRECTION AND
