GLOBKE, Hans

1. STATE SECRETARY HANS GLOBKE STATES RUMORS CIRCULATING IN BRITISH AND AMERICAN CIRCLES THAT ADENAUER HAS ARRANGED MEET BULGANIN IN STOCKHOLM OR OTHER NEUTRAL SPOT FOR SECRET MEETING SOME TIME BEFORE ADENAUER TRIP TO MOSCOW. IT ALSO RUMORED THAT INITIATIVE FOR THIS ARRANGEMENT CAME FROM GERMAN SIDE AND SPECIFICALLY FROM CHANCELLOR'S OFFICE (BUNDESKANZLERAMT) WITHOUT CONSULTING FOREIGN OFFICE.

2. GLOBKE STATED THAT HE WAS INFORMING AMERICAN INTELLIGENCE (AND INTENDED TO INFORM BRITISH) THAT THESE RUMORS HAD NO FOUNDATION IN FACT. THERE WAS NO ARRANGEMENT FOR ADENAUER TO MEET BULGANIN EITHER AT STOCKHOLM OR ANY PLACE ELSE. THE BUNDESKANZLERAMT HAD TAKEN NO INITIATIVE TO ARRANGE SUCH A MEETING AND WOULD NOT RESPOND IF THE INITIATIVE WERE TAKEN BY THE OTHER SIDE.

3. GLOBKE REQUESTS ABOVE INFO BE PASSED TO STATE AND TO GENEVA DELEGATION. INFORMING DOWNING IN BONN.
