ABOUT MID MAY STATE SECRETARY HANS GLOBKE CONFERRED WITH LEADING OFFICIAL FEDERATION GERMAN INDUSTRY (BUNDESVERBAND DEUTSCHEN INDUSTRIE) BDI) ON ITS HEAVY FINANCIAL OUTLAY IN SUPPORT FDP IN NORTH RHINE WESTPHALIA. OFFICIAL LISTENED SYMPATHETICALLY BUT SAID MATTER ENTIRELY IN HANDS GUSTAV STEIN OF BDI BUSINESS MANAGEMENT WHO ISSUES FUNDS BOTH FDP AND CDU.

2. BDI MEMBERS FEEL IN COMMON PRUDENCE THEY MUST SUPPORT FDP IN NRW FINANCIALLY AS LONG AS IT REMAINS MEMBER LAND COALITION AND CONTROLS FINANCE MINISTRY THERE. THIS APPLIES BOTH NOW AND AFTER 6 JULY ELECTIONS, IF FDP REMAINS MEMBER COALITION. DISSEM NONE SUPDATA: [] FROM GLOBKE WHO TALKED WITH FRITZ BERG, BDI PRESIDENT. BONN MAY PASS AMBASSADOR ONLY.
