FOR THIS STARTLING MOVE ON PART ADENAUER. MOST LIKELY IS THAT IT
 BASED HIS HONEST IF MISTAKEN ASSESSMENT WHAT FEDREP MUST DO IN FACE
 SOFTER LINE VIS-A-VIS SOVIETS HE EXPECTS ODOYKE *Take* UNDER NEW
 PRESIDENT. ALSO POSSIBLE HOWEVER THAT IT MACHIAVELLIAN TACTIC TO
 PREVENT BRANDT FROM PUBLICLY EXPLOITING ISSUE ON WHICH GOVT
 GENERALLY AND ADENAUER PERSONALLY LOOKS BAD.

* Hans Gbobe, State Secretary of the Chancellery on behalf of Chancellor Adenauer, discussed with Willy Brandt how to arrive at the quickest possible solution of the problem of interpersonal trade, and asked that Brandt and the Berlin Senate conduct themselves in such a way that no additional difficulties could occur in future negotiations with E. Germany.
