

1. REQUEST BERLIN BDC AND FRANKFURT TRACES ON WERNER THEODOR GOETTSCH, DPOB 23 OCTOBER 1912 IN KIEL. LIVES IN KIEL, ALTE LUEBECKER CHAUSSEE 28. GERMAN NATIONAL. STATISTICIAN FOR RAIFFEISEN GMBH IN KIEL. WIDOWED. TWO DAUGHTERS 25 AND 18 YEARS OLD. JOINED NSDAP IN 1930 AND SS IN 1932 AND WORKED IN SICHERHEITSDIENST. AT END OF WAR WAS OBERSTURMBANNFUEHRER IN AMT VI, RSHA, IN VIENNA. WAS IN U.S. INVESTIGATIVE CUSTODY 1945-48 IN FREILASSING, WIESBADEN, SCHWARZENBORN, STUTTGART, LUDWIGSBURG, AND DACHAU. 1949-50 IN FRENCH INVESTIGATIVE CUSTODY IN INNSBRUCK. 1963-67 WAS UNDER INVESTIGATION BY LAND HAMBURG DISTRICT ATTORNEY FOR ASSISTING THE LATE ALFRED NAUJOCKS IN 1935 IN BURNING DOWN ILLEGAL BLACK FRONT RADPD STATION IN CZECHOSLOVAKIA. LANDGERICHT HAMBURG CLOSED CASE IN MARCH 1967 WITHOUT BRINGING IT TO TRIAL.
2. FRANKFURT: TRACE SERVICES AS PIRL.
3. FRANKFURT AND BERLIN: WOULD APPRECIATE REPLY NO LATER THAN 31 AUGUST 1967.
4. EUR: REFERENCE INADVERTENTLY LISTED INCORRECT SPELLING OF SUBJECT'S LAST NAME. PLEASE CORRECT TO GOETTSCH.
