SUBJECT Operational/CALL Proposed Termination of [CAINFER]		
ACTION REQUIRED - REFERENCES		

Action required: See paragraph 5 below

1. The five meetings held with [CAINFER] in 1969 yielded only three substantive reports, of which only one has been disseminated by Headquarters. We also obtained some background information on two leading [NPD] officials in [CAINFER]'s city.

2. The reasons for the low quantity and quality of production were:

a. [CAINFER] was in poor health during most of this period and was unable to devote much time to his clandestine assignment.

b. Most of what [CAINFER] and his daughter learned at [NPD] meetings was overt and - at best - of marginal interest. [CAINFER] himself has repeatedly stated that [NPD] meetings are like disorganized club meetings where malcontent people meet and have very little of constructive meaning to say to each other.

3. In view of the [September 1969 election results] and the poor record of this operation in the past, we propose to terminate [CAINFER] after one or two more meetings. There appears to be little likelihood now that he will ever gain access to the [national leadership of the NPD] in spite of his background.

4. [CAINFER]'s daughter, a fairly bright and stable woman [of 21 years], does present potential as a long-range penetration asset of the [NPD] or any other [right-wing radical] element. If Headquarters is interested in such a penetration, we could attempt to develop her in this direction.
