This approval is, except under extraordinary circumstances, granted only when the agent involved is subject to capture, i. e. behind the Iron Curtain.</p> <p>2. Once issued, the "L" Pills are under constant control by the case officer and are only issued to the agent immediately prior to agent's border crossing. The pill is returned to the case officer as soon as the agent returns.</p> <p>3.
