Career: On Jan. 1, 1927, he entered the Criminal Police (Kripo) service. On April 1, 1927, he was appointed candidate for a position as "Kriminal-Kommissar". On May 1, 1929 he was appointed "Kriminal-Kommissar" for life. Departmental chief (Dienststellenleiter) with the detective force in Bochum (Oct. 10, 1928 - Dec. 31, 1935). Teacher at the "Sicherheitspolizei" Fuehrer School (no dates given). 1943-1944 he was a member of the Criminal Police Office in Koblenz (it is not known since when), and from there he was appointed "Sicherheitspolizei" and "SD" Commander in Paris, where he remained until August 1944.

Upon cancellation of this post he was transferred to the Criminal Police (Kripoleitstelle), Berlin on September 1, 1944.

Promotions: Kriminalrat (Councillor on Crime) June 1, 1939  
Kriminaldirektor (Director of Criminal Police) May 31, 1943.

The SS-Military Police Court and the Police Court in den Haag passed sentence on him and other SS-Officers. The purpose of this sentence and for which offense it was passed, is not stated.
